RECOGNITION ORDER

1. WHEREAS in terms of Section 14(1) of the NCTE Act, 1993, Shri Krishna Avdhoot D.Ed College, P.C No. 18, Plot No. 164/3b, Kokna (Navegaon) Bandh, Tah Sadak/ Arjuni, Dist. Gondia, Maharashtra. (APW07055/1222090) had submitted on 31.12.2007 the application to the Western Regional Committee of the NCTE for grant of recognition for starting the D.Ed. (M) (Co.Ed) Course with an annual intake of 50.
2. And whereas, the inspection of the institution was conducted on 18/10/2008. The matter was placed in WRC in its 110th meeting and committee decided to No further process as per decision taken by WRC under agenda item 110.06. Accordingly letter issued on 13/4/2009.
3. And whereas, the institution prefer appeal to NCTE Headquarters under section 18 of the NCTE Act, 1993 and appellate authority passed order dated 14/7/2009, the appeal was rejected and WRC order dated 13/4/2009 was confirmed.
4. And whereas, the institution filed W.P. No. 7008/2009 in the High Court of Judicature at Bombay Bench at Aurangabad. The Hon'ble High Court passed order dated 11/6/2010. The operative part of the order is as follows: "In that light of the matter, we are inclined to allow this petition and consequently we allow the petition and quash and set aside the impugned orders. The respondent No. 3 shall remand the matter back to the respondent No. 2 for a de novo decision afresh from the stage of scrutiny/permission to the petitioner institute for the academic year 2010-2011. The respondent No. 2 shall take into consideration the ratio laid down by the Supreme Court in the aforesaid judgement. The respondent No. 2 shall deal with the application on its own merits and pass orders, in accordance with law, as expeditiously as possible. Rule is thus made absolute on the above terms with no order as to costs.
5. And whereas, the matter was placed in WRC in its 144th meeting and the committee decided to Issue the letter of Intent prior to recognition under clause 7(9) of NCTE Regulations 2009. Accordingly letter issued on 16/2/2011.
6. And whereas, the institution submitted reply dated 31/3/2011 was placed before WRC in its 148th meeting and committee decided to show cause notice be issued to the institution on following points:
- One of the staff members is not qualified as per the NCTE norms.
 - Teaching experience certificate of the Principal not submitted.
 - Staff list approved by examining body not submitted.
7. And whereas, show cause notice issued to the institution on 25/4/2011. The institution submitted reply dated 17/5/2011 was placed before WRC in its 150th meeting and committee decided to grant recognition under section 14(3)(a) of NCTE Act, 1993 and clause 7(11) of NCTE Regulations 2009 for D.Ed. (M)(CO.ED.) with an annual intake of 50 seats from academic session 2011-2012.
8. Now therefore, in exercise of the powers vested under Section 14 (3) (a) of the NCTE Act, 1993, the Western Regional Committee hereby grants recognition to Shri Krishna Avdhoot D.Ed College, P.C.No. 18, Plot No. 164/3b, Kpkna (Navegaon) Bandh, Tah Sadak/ Arjuni, Dist. Gondia, Maharashtra: (APW07055/1222090) for starting D.Ed. (M) (Co.Ed) Course of (Elementary) level of (2 Years) with an annual Intake of 50 from the academic session 2011-2012.

9. Further, the Institution is required to comply with all post-recognition conditions enumerated from Clause 8(11) to Clause 8(16) of NCTE (Recognition, Norms & Procedure) Regulations 2009.

10. The society sponsoring the Institution shall transfer and vest the title of the land and building in the name of the institution within a period of six months from the date of this order and submit the documents to the Western Regional Committee. However, in case the society fails to do so due to local laws or rules or bye-laws, it shall intimate in writing with documentary evidence of its inability to do so.

11. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms and Procedure) Regulations, 2009 for the academic session 2011-2012 falling which the recognition will be effective from the academic session 2012-2013.


12. The recognition will operate for 2011-2012 only if the requirement of 200 teaching days in the session is fulfilled as per calendar of the University/Affiliating Body.

13. The institution shall ensure that the required number of academic staff for conducting the course is always in position.

14. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its Official website.

15. If, at any time, either on *sue-moto* inspection or on any representation received from any person, the WRC, NCTE is satisfied that the Institution has contravened any of the provisions of the NCTE Act, or the rules, regulations, orders made or issued there under or any condition subject to which the recognition/permission was granted, the recognition/permission may be withdrawn under the provisions of Section 17 (1) of the NCTE Act.




